ORDINANCE NO. <u>5</u> -2018- /

AN ORDINANCE AMENDING THE RATES AND CHARGES FOR THE SEWAGE WORKS UTILITY

WHEREAS, the Kirklin Sewer Works ("Sewer Works"), in Kirklin, Indiana ("Town") operates a sewage works utility for the benefit of the ratepayers within the Town;

WHEREAS, various ordinances have been adopted from time to time regarding policies and procedures for the sewer works and the establishment of sewer rates, fees and charges;

WHEREAS, the existing rates, fees and charges are set forth in the earlier ordinance, Ordinance No. 6-2017-1, adopted on June 5, 2017;

WHEREAS, the Town has determined that the prior ordinance contained an error in the manner of the computation of the late charges on late payments and that the ordinance should be amended to correct this error because the previous manner of computation of late charges was more efficient, fair and equitable.

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLIN, as follows:

1. SEWER RATES – the late fee charges shall be amended and all other rates shall remain unchanged for use of and service rendered by the sewer works, each user shall be charged in an amount based upon a fee schedule, as shown in Appendix A.

All other provisions of the Town's current sewer rates and charges not amended by this ordinance shall remain in full force and effect.

The provisions herein, when approved and adopted, shall be effective beginning with the May 2018 consumption period and billed for the June 2018 billing period.
